Tournament Regulations

1. All entries are due no later than Wednesday, June 3, 2009.
2. This tournament will be governed by USTA rules & regulations, however the tournament is *not sanctioned by the USTA*.
3. No entries will be accepted by phone or without full payment . No refunds will be given after the draw has been made.
4. Players are responsible for finding out playing times. First match times will be posted on the internet at: www.barnestenniscenter.com
5. Players must be ready to play 15 minutes prior to their first match. The "15 minute default" rule will be in effect .
6. The draw for each event may need to be limited to the first 32 entrants. Entries will be accepted on a first -come basis.
7. Warm-up will be limited to 10 minutes, including serves.
8. Each player may enter only one event.
9. Matches for 9,10, and 11 year olds will be the best two out of three sets with a 12 -point tie breaker at six-all. 8 & under division will play a 10-game Pro Set. No-Ad Scoring may be used if necessary.
10. Age Eligibility:
 - 11 & under if born on or after January 1, 1998
 - 10 & under if born on or after January 1, 1999
 - 9 & under if born on or after January 1, 2000
 - 8 & under if born on or after January 1, 2001
11. Consolation round will be held for first match losers—these will be a shortened match format.
12. Awards will be presented to the winner and runners-up in each age division and also to the consolation winners and runners-up.
13. T-shirts will be given to all participants.
